2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

**May 5, 2018**

**ELIGIBILITY:** Open to any player age 15 and older who is a currently registered member of Hudson Judo Yudanshakai (USJF). Men's, Women's, and Masters Divisions. **ALL COMPETITORS MUST SHOW A CURRENT HUDSON/U.S. JUDO FEDERATION CARD AT THE VENUE. NO OTHER MEMBERSHIPS WILL BE ACCEPTED.**

**USJF Sanction # 18-05-07**

Rules: Current IJF Rules with the following modifications:

- a) Competition time – 3 min.
- b) Round robin in all divisions
- c) Mat size – 4 mats  
8m x 8m playing area with 4m safety area between each mat and on the outside.
- d) **All contestants must wear a white gi** in order to be allowed to compete in this competition. **No blue gis will be permitted.**
- e) There will be **no kansetsu-waza** allowed in the **Novice Division.**
- f) CARE system will not be in use in this competition.
- g) Some rank divisions maybe combined, depending on the amount of players available.
- h) All matches will be contested in round robin divisions.
